

Dear Church,

As you can imagine, the situation involving COVID19 is ever evolving, and making decisions as to how and when to re-open our church services and building use has been a challenge. I wrote a letter earlier that outlined the four commands that are driving the decision making process, and that has not changed. We have become more and more aware of the challenge of having indoor services at this time considering the various perspectives about this virus among our own body. Eph. 4:1-3 says, "I therefore, a prisoner for the Lord, urge you to walk in a manner worthy of the calling to which you have been called, with all humility and gentleness, with patience, bearing with one another in love, eager to maintain the unity of the Spirit in the bond of peace." I cannot think of a more appropriate passage of Scripture for the situation we find ourselves in. Part of bearing with one another is respecting various perspectives and concerns about this virus, though they may be different. We also know that every single person is valuable to the body and most (if not all) have a strong desire to gather together for worship. Our task as elders was to put together a plan that provides a safe way for all our people to gather as one body. We have developed a phased plan to help us wrap our minds around how and when our buildings and ministries will be opened up. Our hope is to provide at least some clarity to this question. We also realize that things are always changing, so we do not view this plan as "set in stone". We fully expect to revise it as new information comes out. The following graphic is our attempt to help make sense of all this. For reference, based on the Governor's lifting of some restrictions this past Monday, we consider ourselves to be in Phase 1 of this plan.

Visits to FBC members and public spaces as needed within state guidelines.	Resume staff activities, buildings and office use, and visits with FBC members and general public.
What driving factors move us between phases?	The elder board will determine when FBC moves from one phase to another based on our understanding of the situation within our body as well as in coordination with guidance provided by our state and local government.

As you can see in this phased plan, we will be offering an outdoor service starting June 7<sup>th</sup> at 9:30am. This service is weather permitting, and if it is canceled due to weather, we will direct people toward our online service. We will still be recording our service for those that do not feel comfortable gathering together at our outdoor service and for home worship if our service is canceled. We have developed a page on our website that will give you the information that you need to participate in the service. On this page you will find:

- Information about the outdoor service.
- Access to lyrics for the songs that we will be singing that morning in a pdf document, which you can either print out ahead of time or view from your mobile device.
- Suggestions on what to bring to help with the sun or bugs.
- Information about cancellation. If the service is canceled due to weather, we will post it on that page, email out that information the morning of the service, and post it on our FBC Facebook page.
