#### **Romans 8:1-4**

1 There is therefore now no condemnation for those who are in Christ Jesus. 2 For the law of the Spirit of life has set you free in Christ Jesus from the law of sin and death. 3 For God has done what the law, weakened by the flesh, could not do. By sending his own Son in the likeness of sinful flesh and for sin, he condemned sin in the flesh, 4 in order that the righteous requirement of the law might be fulfilled in us, who walk not according to the flesh but according to the Spirit.

### **Discussions Questions**

- 1. When Paul states that there is no condemnation for those in Christ Jesus, how does that sit with your spirit? Do find it life giving? Why or why not?
- 2. We often talk about the work of Jesus in securing our salvation through His death on the cross, but rarely do we talk about the Holy Spirit's work in sanctifying us as believers. Why do you think that is the case?
- 3. Pastor Jon laid out a few examples of those who may claim faith in Christ but may not truly belong to Him. He mentioned the absence of any fruit of the Spirit, a lack of conviction or brokenness over your own sin, and a lack of desire for the things of the Lord. Can you think of other examples of that would indicate that a person who claims Christ might not truly belong to Christ?
